Minutes of the 138th Annual General Meeting of the Durham County Football Association held on Thursday 25th August 2022, at the Durham County FA Headquarters.

1. Chairman's welcome:

The Chairman stated that it was a privilege and an honour to open the Association's 138th Annual General Meeting, which is the Twentieth as a Limited Company.

The Chairman then introduced the Board of Directors before welcoming members of Council.

Congratulations were given to the England Women's team on winning the Euros.

Mel thanked all who attended and to all the volunteers who keep the game at grassroots level thriving.

3. Minutes of the 137th Annual General Meeting:

The minutes of the 137th Annual General Meeting of the Association held on Wednesday 8th December 2021, having been previously circulated were confirmed as a true record by Clem O'Donovan and John Morton and duly signed by the Chairman with no matters arising.

4. To receive the Directors report for the period ended 30th June 2021:

The Treasurer stated that we had had another good year although the accounts showed a loss from the 2020 accounts the Association had still made a profit.

The Associations total reserves stand at £3.1m however a large percentage is ring fenced for a new football hub.

In accordance with Article 52 the Chairman congratulated the four Vice Presidents on their reelection and added that the Association was fortunate to have them as they were very actively involved in The Associations business and County affairs and he thanked them for their continuous support.
