

## Whole Game System Business Release Notes – 30th May

WGS Release Notes: 29/05/19

Expected Date/Time: 30th May 0700 - 0900.

The WGS release scheduled on the above date is expected to contain the following updates and enhancements:

### WGS Portal Player Registration Changes

- When creating a player, a Club official can now save and request online consent using one button, rather than having to perform this in multiple steps.
- Club Player Registration tab:
  - Additional filter of 'ID Check' added.
  - The green tick to indicate that consent has been given by player has been removed from Club Player Registration page.
- For Club Officials, there is now the function to export a list of players in the Club as a csv file from the Player Registration tab:
  - 'Export players' button added to the filters bar.
  - This is available to the following roles: Club Secretary, Club Secretary Assistant, Club Secretary (temporary), Club Chairman, Club Player Registration Officer, Club Welfare Officer.
  - Users that use this function will be logged in the GDPR Audit, as required by GDPR guidelines.
- For League Officials on 'Player Registration Reqs' tab:
  - 'Number of forms' of ID field is now a drop down field with values '0', '1' and '2'.
  - Change to prevent 'acceptable forms of ID' from being selected if the number of forms of ID required is '0'.
  - 'Last ID Check Date' field removed
  - 'Email Address for Queries' field removed
  - Export players button added to the filters bar
  - 'Export players' file now includes additional columns (Registration Start and End dates)
- Age Band for Wheelchair teams extended to allow any player who is 6 years old or older.
- Changes for adding players to disability teams:
  - Age Bands for disability teams (excluding wheelchair) who are U18 will have a 3 year age banding.
  - Age Bands for disability teams (excluding wheelchair) who are U16 will have a 4 year age banding.
  - Players of any gender can be added to a disability team. League Sanction Changes

## Changes to the League Sanction

- Changes to form in section 3: removal of sections 3.1, 3.2 and 3.3.
- Divisions, Devt Groups and Cups need to be updated in the League Sanction tab, not the League Sanction form.
- Users need to confirm that this has been completed in order to complete section 3.
- League Structure tab season is changed to next season when the League Sanctioning form is started and 'In Progress'.
- Teams tab season drop down updates to next season when the League Sanctioning form is started and 'In Progress'. The current season can still be found in the season drop down field on this tab.

## Discipline

- Ability for referees to record sin bins for matches at all levels Step 5 and below, in preparation for the new season.
- Sin Bin exemption tick box added in CRM to exclude competitions from Sin Bin (only FA Discipline team able to update).

## Other

- A Team Coach/Manager can now access player email list page for each of their teams (if they coach/manage multiple teams).
- Change to role name: 'Full-Time SMS Contact' is now "County Cup SMS Contact'.
- Change to role name: 'Full-Time Email Contact' is now 'County Cup Email Contact'
- Technical: changes to the Club Players page to improve page load time.
- Technical: change to the database query that calculates the count of players at top of Player reg tab, to improve page load times.

## WGS CRM

### League Sanction Changes

- Changes to the League Sanction areas of CRM, including dialogues to support changes made in the Portal and removal of section 3.1, 3.2, 3.3.

### Discipline

- Discipline – Fix to resolve duplicate CLUB-Player memberships being created when charging cases.
- Fix to letters to correctly show sin bin cautions that generate a suspension.

## Bug Fixes

- Change to 'Known As' and 'Preferred Name' fields in CRM to prevent them being automatically updated with a player's first name.
- Error fixed on Safeguarding Visits tab.
- Update to some portal notifications to include FAN of individuals referenced.
