

South West Hertfordshire Football Association – Watford Sunday Football League

This document contains the Standard Code of Rules developed by The Football Association for open age football (the "Standard Code"). The Standard Code is mandatory for all Competitions at Regional NLS Feeder League level and below, and Tier 7 and below of The FA Women's Pyramid-

These Rules cover the following competitions: SW Herts FA Watford Sunday Football League, SW Herts FA Sunday Challenge Cup, SW Herts FA Intermediate Cup, SW Herts FA Sunday Junior Cup, Watford Sunday League Invitation Cup, Watford Sunday League Presidents Cup, Watford Sunday League Reserve Cup, and any other such Competitions as the Association may wish to organize.

RULES IN NON-BOLD ITALICS ARE RULES INTRODUCED BY THE WATFORD SUNDAY FOOTBALL LEAGUE, OR MAY BE ALTERNATIVES PROPOSED TO THE MANDATORY RULES BY THE FA. THESE MAY BE AMENDED OR ADDED TO AT THE AGM.

ALL OTHER RULES IN BOLD TYPE ARE FA MANDATORY RULES AND CANNOT BE AMENDED OTHER THAN BY THE FA.

1. DEFINITIONS

1.A	In these Rules:
	"Affiliated Association" means an Association accorded the status of an Affiliated Association under the rules of The FA.
	"AGM" shall mean the annual general meeting held in accordance with the constitution of the Competition.
	"Club" means a club for the time being in membership of the Competition.
	"Club Portal" means the system used by Clubs to affiliate teams as determined by The FA from time to time;
	"Competition" means the South West Hertfordshire Football Association - Watford Sunday Football League.
	"Competition Match" means any match played or to be played under the jurisdiction of the Competition.
	"Contract Player" means any Player (other than a Player on a Scholarship) who is eligible to play under a written contract of employment with a Club.
	"Deposit" means a sum of money deposited with the Competition as part of the requirements of membership of the Competition.
	"Fees Tariff" means a list of fees approved by the Clubs at a general meeting to be levied by the Management Committee for any matters for which fees are payable under the Rules, as set out at Schedule A.
	"Fines Tariff" means a list of fines approved by the Clubs at a general meeting to be levied by the Management Committee for any breach of the Rules, as set out at Schedule A.
	"Ground" means the ground on which the Club's Team(s) plays its Competition Matches.
	"Management Committee" means in the case of a Competition which is an unincorporated association the management committee elected to manage the running of the Competition and where the Competition is incorporated it means the Board of Directors appointed in accordance with the articles of association of that company.
	"Match Officials" means the referee, the assistant referees and any fourth official appointed to a Competition Match.
	"Non Contract Player" means any Player (other than a Player on a Scholarship) who is eligible to play for a Club but has not entered into a written contract of employment.
	"Officer" means an individual who is appointed or elected to a position in a Club or Competition which requires that individual to make day to day decisions.
	"Participant" shall have the same meaning as set out in the rules of The FA from time to time.
	"Player" means any Contract Player, Non Contract Player or other player who plays or who is eligible to play for a Club.
	"Player Registration System" means The FA system to register players as determined by The FA from time to time.
	"Playing Season" means the period between the date on which the first competitive fixture in the Competition is played each year until the date on which the last competitive fixture in the Competition is played.
	"Rules" means these rules under which the Competition is administered.
	"Sanctioning Authority" means the Hertfordshire County Football Association Limited.
	"Scholarship" means a Scholarship as defined in The FA rules.
	"Season" means the period of time between one AGM and the next AGM
	"Secretary" means such person or persons appointed or elected to carry out the administration of the Competition.
	"SGM" means a special general meeting held in accordance with the constitution of the Competition.
	"Team" means a team affiliated to a Club, including where a Club provides more than one team in the Competition in accordance with the Rules.
	"The FA" means The Football Association Limited.
	"Virtual Meetings" means meetings held electronically
	"written" or "in writing" means the representation or reproduction of words or symbols or other information in a visible form by any method or combination of methods, whether sent or supplied in electronic form or otherwise.

5.A	The Management Committee shall comprise the Officers of the Competition and 2 members who shall all be elected at the AGM.

In the event of there being no nomination for any office by the date stated in the earlier part of this Rule, nominations may be received at the AGM.
5.C	The Management Committee shall meet a minimum of twice a season or as and when required,
	On receiving a requisition signed by two-thirds (2/3) of the members of the Management Committee the Secretary shall convene a meeting of the Management Committee.
5.D	Except where otherwise mentioned all communications shall be addressed to the Secretary who shall conduct the correspondence of the Competition and keep a record of its proceedings.
5.E	All communications received from Clubs must be conducted through their Officers and sent to the Secretary. Failure to comply with this Rule will result in a fine in accordance with the Fines Tariff. (Note ; Officers consist of the 4 nominated persons signing the Competitions Undertaking Form, i.e. Chairman, Secretary, Treasurer, Manager.)
5.F	No member shall be eligible for election as a Vice President unless he/she has been deemed and proposed, by the Management Committee, to have provided meritorious service to the Association for a minimum continuous period of ten years from the date of their appointment to their position. Clubs may submit names of persons to the Management Committee for consideration under the above definition. All current Honorary positions will, under this Rule, be reviewed annually and members of the association meeting the requirements of Rules 5F and 5G will be proposed, and seconded for election at each Annual General Meeting. Other notable Honorary members of the Association will be proposed and seconded for election at each Annual General Meeting.

	Members may attend meetings but are not eligible to vote.
5.G	When Association Officers retire, the President may be nominated to become an Honorary Life Past President of the Association, and in the case of a Vice President may be nominated to become an Honorary Life President of the Association. Other Officers will be subject to qualification for Vice President under Rule 5F.
5.H	On Association Meeting nights, each Club in membership will be required to send a representative to the meeting. Voting will be as prescribed in Rule 6D. Clubs not represented at Competition (clubs) Meetings shall be fined £25. After missing two consecutive meetings, a written explanation must be sent to the Honorary Secretary within seven days of the date of the meeting giving reasons for non- attendance. Clubs missing three consecutive meetings will be required to appear before the Management Committee who may impose an additional fine.
6. POWERS OF	MANAGEMENT
6.A	The Management Committee may appoint sub-committees and delegate such of their powers as they deem necessary. The decisions of all sub-committees shall be reported to the Management Committee for ratification. The Management Committee shall have power to deal only with matters within the Competition and not for any matters of misconduct that are under the jurisdiction of The FA or Affiliated Association.

	Where required, hearings shall take place as soon as reasonably practicable following receipt of the reply of the Club as more fully set out above.
	With the exception of Teams playing at Regional NLS Feeder League of the National League System, the maximum fine permitted for any breach of a Rule is £250 and, when setting any fine, the Management Committee must ensure that the penalty is proportional to the offence; taking into account any mitigating circumstances.

	No Participant under the age of 18 can be fined.

Clubs failing to satisfactorily attend to the business and/or the correspondence of the Competition shall be liable to be penalized at the discretion of the Management Committee. The penalty may include having its membership withdrawn (subject to SGM appeal)
6.J	Subject to a Club's right of appeal in accordance with Rule 7 below, all fines and charges must be paid within 14 days of the date of notification of the decision. Any Club failing to do so will be fined in accordance with the Fines Tariff. Further failure to pay the fine including the additional fine within a further 14 days will result in fixtures being withdrawn until such time as the outstanding fines are paid. 6.M	The business of the Competition as determined by the Management Committee may be transacted by electronic mail or facsimile.
6.N	The Minutes of the Management Committee of the Association shall include confirmation of any fines imposed at the meeting.
6.0	Any Management Committee Member who fails to attend three consecutive meetings, without a written explanation, shall be deemed to have resigned their post.
6.P	A Club who is deemed guilty of a breach of the Rules that is liable to bring The Association into disrepute will be dealt with as the Committee determine and may have its membership removed as per Rule 12. Written notification of a charge of disrepute against a Club must be given and the Club will have right of protest as per Rule7B and any subsequent appeal under Rule 16. Clubs are responsible for the behavior of their supporters.

12.C	Any Officer or member of a Club found guilty of either a breach of Rule, other than field offences, or of inducing or attempting to induce a Player or Players of another Club in the Competition to join them shall be liable to such penalty as a General Meeting or Management Committee may decide, and their Club shall also be liable to expulsion in accordance with the provisions of 12.A and/or 12.B of this Rule. <i>Any action taken under this Rule will be reported to the Sanctioning Authority.</i>

13.A	The following agreement shall be signed on behalf of the winners of the cup or trophy:
	"We (A) (name) and (B) (name), the Chair and Secretary of [] FC (Limited), members of and representing the Club, having been declared winners of cup or trophy, and the cup or trophy having been delivered to us by the Competition, do hereby on behalf of the Club jointly and severally agree to return the cup or trophy to the Competition Secretary on or before the date of the March Competitions (Clubs) meeting. If the cup or trophy is lost or damaged whilst under our care we agree to refund to the Competition the amount of its current value or the cost of its thorough repair."
	Failure to comply will result in a fine in accordance with the Fines Tariff.
13.B	At the close of each Competition awards may/shall be made to the winners and runners-up if the funds of the Competition permit.
13.C	A Competition Cup or Trophy shall be vested in the Association Sanctioning the Competition as Trustees. If a Competition be discontinued for any reason, the Cup or Trophy shall be returned to the donor, if he conditions attached to so provide, or otherwise dealt with as the Competition may decide.
13.D	Any Club failing to return trophies by the date of the March Club Meeting of the following season, as required by this Rule shall be fined not less than £25.
13.E	The winning team and runners-up in each Division of the Competition, and various cups, shall receive 16 mementoes to be provided by the Competition.
13.F	The winning teams and runners-up of all competitions may make application to the Management Committee for permission to purchase extra mementoes for which they must pay. This application must state the full names of the players for whom the extra mementoes are required, and the number of games each player has played in the competition for his Club, in the same season.
13 G	All teams receiving a Cup or trophy from the Competition at the end of the season shall ensure that before it is returned to the Competition, that it is engraved with the winning clubs name and season of winning, plus is cleaned to the standard it was when received by them. Failure to comply will result in a fine in accordance with the Fines Tariff.
14. ALTER	RATION TO RULES
14.A	Alterations, for which consent has been given by the Sanctioning Authority, shall be made to these Rules only at the AGM or at an SGM specially convened for the purpose called in accordance with Rule 9. Any alteration made during the Playing Season to these Rules shall not take effect until the following Playing Season, except in exceptional circumstances where approved by Sanctioning Authority and The FA.
14.B	Notice of proposed alterations to be considered at the AGM shall be submitted to the Secretary by 1^{st} April in each year. The proposals, together with any proposals by the Management Committee, shall be circulated to the Clubs by 14^{th} April and any amendments to these proposals shall be submitted to the Secretary by 21^{st} April. The proposals and proposed amendments to these proposals shall be circulated to Clubs with the notice of the AGM. A proposal to change a Rule shall be carried if a majority of those present and entitled to vote and voting are in favour.
14.C	A copy of the proposed alterations to Rules to be considered at the AGM or SGM shall be submitted to the Sanctioning Authority or The FA (as applicable) at least 28 days prior to the date of the meeting.
15. FINAN	
15.A	The Management Committee shall determine with which bank or other financial institution the funds of the Competition will be lodged.
15.B	All expenditure in excess of £500 shall be approved by the Management Committee. The financial year of the Competition will end on 15 th May each year.
<u>15.C</u> 15.D	The accounting records or a certified balance sheet, of a Competition shall be prepared and shall be
15.E	[audited/verified] annually by a suitably qualified person(s) who shall be appointed at the AGM.Each Club must ensure that all monies owed to the Club by its members is collected from them by the last day of the season, the date of which was agreed at the previous Annual General Meeting. Any monies owed after this date is the Club's own responsibility and cannot be referred to the League. If, however any of such debt relates to a Herts FA fine, Clubs may refer the matter to the Herts FA for any appropriate action. But any such referral to

	Herts FA must be within 28 days of payment being requested or within 112 days of the debt being incurred.
16. INSURAN	ČE CONTRACTOR CONT
16.A	All Clubs must have valid Public Liability Insurance cover for a minimum of ten million pounds (£10,000,000) at all times.
16.B	All Clubs must have valid personal accident cover for all Players registered with them from time to time. The Players' Personal Accident Insurance cover must be in place prior to the Club taking part in any Competition Match and shall be at least equal to the minimum recommended cover determined from time to time by the Sanctioning Authority. In instances where The FA is the Sanctioning Authority, the minimum recommended cover will be the cover required by the Affiliated Association to which a Club affiliates.
16.C	Failure to comply with Rule 16.A or 16.B will result in a fine in accordance with the Fines Tariff.
17. DISSOLU	TION
17.A	Dissolution of the Competition shall be by resolution approved at an SGM by a majority of three quarters (3/4) of the members present and shall take effect from the date of the relevant SGM.
17.B	In the event of the dissolution of the Competition, the members of the Management Committee are responsible for the winding up of the assets and liabilities of the Competition.
17.C	 The Management Committee shall deal with any surplus assets as follows: Any surplus assets (save for a trophy or any other presentation), remaining after the discharge of the debts and liabilities of the Competition shall be transferred only to another Competition or Affiliated Association or The Football Association Benevolent Fund or to such other charitable or benevolent object in the locality of the Competition as determined by resolution at or before the time of winding up, and approved in writing by the Sanctioning Authority.
	 If a Competition is discontinued for any reason a trophy or any other presentation shall be returned to the donor if the conditions attached to it so provide or, if not, dealt with as the Sanctioning Authority may decide.

MATCH RELATED RULES

18. Q	UALIFICATION OF PLAYERS		
18.A	A Player is one who, being in all other respects eligible, has:		
	1. Registered through the Player Registration System and received approval from the Competition.

2. signed a fully and correctly completed Competition Emergency Registration form in ink on a match day prior to playing which is countersigned by an Officer of the Club and witnessed by an Officer of the opposing Club, and submitted to the Competition within four days (Sundays excluded) subsequent to the Competition Match. The Player shall not play again in a subsequent match in the Competition until the Club has registered the player through The FA Player Registration System and is in possession of the approval from the Competition. This applies to League (not Cup) matches only and up to two per match and a maximum of 20 per season. Emergency Registrations can only be done up until the 20th February each season. Also clubs are advised that they should check that players are not registered to another club in the competition or suspended before Emergency Registering them

Note: The countersigning does not validate the registration of the player concerned: the validation will be completed by the procedures at below. The completed form must be dealt with as follows, the Form must be sent as per the instructions on it and the Emergency Registration Fee of £10 (which includes the Registrations Fee paid into the Leagues bank account). The completed form must be submitted within four days of the match. The Club making such Emergency Registrations will be held liable for any breaches of the Rules, which may be uncovered after the event, e.g. registering a suspended or otherwise ineligible player etc. An Emergency Registration Form will be accepted, subject to the provisions of this Rule, without a photograph. However, a formal Registration must then be submitted within 5 days as required by Rule 18(A)1. Any breach of this Rule will be subject to a £10 fine together with any other required action for any other breach of Rules uncovered under 18A above.

3. Players Registered through the Player Registration System (18A1) must be done 3 days prior to the Player playing. When clubs register players they must also download the players photo onto the Player Registration System otherwise the registration will not be accepted. Also clubs are advised that they should check that players are not registered to another club in the competition or suspended before Emergency registering them._

A player is NOT registered until the Club Secretary receives Player Registration System approval from the Competition (with the exception of Emergency Registrations) and will be subject to Rule 18M.

	Any registration that is not fully and correctly completed will be returned to the Club unprocessed and the player classed as unregistered. If a Club attempts to register a player via the Player Registration System but does not fully and correctly complete the necessary information via-the Player Registration System the registration will not be processed.
	For Clubs registering Players under Rule 18.A.2. registration forms will be provided in a format to be determined by the Competition. For Clubs registering Players by the Player Registration System, Clubs must access the Player Registration System in order to complete the registration process.
	Failure to comply with this Rule will result in a fine in accordance with the Fines Tariff.
18.B	1. Contract players are not permitted in this Competition with the exception of those Players who are registered under Contract with the same Club who have a team operating at Steps 1 to 6 of the National League System, or Tiers 1 – 4 of the Women Pyramid System.
	2. It is the responsibility of each Club to ensure that any Player registered to the Club has, where necessary, the required International Transfer Certificate. Clearance is required for any Player aged 10 and over crossing borders including Wales, Scotland and Ireland.
	3. Each team must have at least <i>11</i> Players registered <i>14</i> days before the start of each Playing Season. Failure to comply with this Rule will result in a fine in accordance with the Fines Tariff , and team will not be qualified to play on the first day of the season.
	4. In the event of a Non Contract Player changing their status to that of a Contract Player with the same Club, or with a Club in another Competition their registration as a Non Contract Player will
	automatically be cancelled and declared void unless the Club conforms to the exception detailed in Rule 18.B.1.
	5. Any Club registering a player, after the 14-day deadline in Rule 18B 3 and between the 1 st Sunday in September, must submit to the Registrations Secretariat a written explanation why the registration is required, together with the sum of £10, which includes Registration Fee, for each registration required. (see also see Rule 18P)
18.C	A Player that owes a Football Debt (as defined under the Football Debt Recovery Regulations) shall be permitted to register for a Club but <i>will</i> be suspended from football activities if the Player does not comply with the terms of the Football Debt Recovery Regulations in respect of that Football Debt.
18.D	A fee as set out in the Fees Tariff shall be paid by each Club/Team for each Player registered.
18.E	The Management Committee shall decide all registration disputes.
	In the event of a player signing a registration form or having a registration submitted for more than one Club the valid registration submitted first shall take precedence. The Secretary shall notify the Club last applying to register the player of the fact of the previous registration.
18.F	It shall be a breach of Rule for a Player to:
	1. Play for more than one Club in the Competition in the same Playing Season without first being transferred.
	2. Having registered for one Club in the Competition, register for another Club in the Competition in that Playing Season except for the purpose of a transfer, or where the Competition adopts Rule 18P.
	3. Submit a signed registration form as per Rule 18 A.2 or submit a registration through the Player Registration System –that the Player had willfully neglected to accurately or fully complete.
	Failure to comply with this Rule will result in a fine in accordance with the Fines Tariff.
18.G	1. The Management Committee shall to accept the registration of any Player subject to the provisions of Rules 18.G.2 and 18.G.3 below.
	2. The Management Committee shall have power to refuse, cancel or suspend the registration of any Player or may fine any Player, at their discretion (in accordance with the Fines Tariff) who has been charged and found guilty of registration irregularities (subject to Rule 7).
	3. The Management Committee shall have power to make application to refuse or cancel the registration of any Player charged and found guilty of undesirable conduct (subject to Rule 7) subject to the right of appeal to the Sanctioning Authority. Application should be made to the parent County of the Club the Player is registered or intending to be registered with.

	Undesirable conduct shall mean an incident of repeated proven misconduct, which may deter a Participant from being involved in this Competition.
	4. A Player who has previously had a registration removed in accordance with Rule 18(G)(iii) but has a registration accepted at the expiry of exclusion will be considered to be under a probationary period of 12 months. Whilst under a probationary period, should the Player commit a further act of proven misconduct under the jurisdiction of the Competition, (excluding standard dismissals), the Competition may consider a further charge of bringing the Competition into disrepute.
	(<i>Note:</i> Action under Rule 18.G.3 shall not be taken against a Player for misconduct until the matter has been dealt with by the Sanctioning Authority, and then only in cases of the Player bringing the Competition into disrepute and will in any event be subject to an appeal to the Sanctioning Authority or The FA. All decisions must include the period of restriction. 	A Player may not be registered for a Club nor transferred to another Club in the Competition after 8pm on the 20 th

18.J	Registrations are valid for one Playing Season only.
18.K	A Player shall not be eligible to play for a Team in any special championship, promotion or relegation deciding Competition Match (as specified in Rule (22.A) unless the Player has played 3 Competition Matches for that Team in the current Playing Season.
18.L.	Not used in this Competition .
18.M	 Subject to Rule 18M2 any Club found to have played an ineligible Player in a Competition Match or Matches where points are awarded shall have the points gained from that Competition Match deducted from its record, up to a maximum of 12 points, and have levied upon it a fine (in accordance with the Fines Tariff). (NB – A suspended player is ineligible. Any Club, or Club Official breaking this Rule or Rule K on more than two occasions may be excluded from further participation in the Competition)
	2. The Management Committee may vary the sanction as relates to the deduction of points set out at Rule 18M1 in circumstances where the ineligibility is due to the failure to obtain an International Transfer Certificate or where the ineligibility is related to the Player's status.
	3. Where a Club is found to have played an ineligible Player in accordance with Rule 18.M1 above, the Management Committee may also, at its discretion, order one or more of the following (if appropriate):
	 Award the points available in the Competition Match in question to the opponents, subject to the Competition Match not being ordered to be replayed;
	ii. Levy penalty points against the Club in default;
	iii. Order that such Competition Match or Matches be replayed (on such terms as are decided by the Management Committee).
18.N	The following clause applies to Competitions involving Players in full-time secondary education:
	 Priority must be given at all times to activities of schools and school organisations. Failure to comply with this Rule will result in a fine in accordance with the Fines Tariff. The availability of children and young people must be cleared with the Head Teachers or Principals
	(except for Sunday leagues competitions).3. To play open age football the player must have achieved the age of 16.
18.0	A Player who has played for a Team in a higher division 6 times , including cup games, or more shall not in that Playing Season be eligible to play in a lower division, including cups, except by permission of the Management Committee. Application must be received 5 days prior to the match date .

18.P	If a Club wishes to cancel a Player's registration within the Competition, it must make a request via The FA's electronic player registration system giving the reasons for the request. The Competition may either approve or decline the request.	
	If a Player's registration is cancelled they will not be eligible to re-register in the Competition for a period of 7 days from the date of cancellation.	
18.Q	1. It will be the responsibility of the Club Secretary to ensure that player photos (either printed sheets or electronically) are available at all League and Cup matches for production when required at any time up to 15 minutes after the end of the match by their opponents. A member of the Management Committee, in an official capacity, is not time limited on the match day for requesting sight of or the checking Photographs.	
	2. It is compulsory for the Club Secretary or in their absence, an assigned club representative to inspect the opposition's Photographs prior to the match and to report any infringements to the Management Committee. This procedure need not be carried out if a member of the Management Committee has already carried out a Full Player Photographs inspection.

If the Photographs are not presented when required as in (i) and (ii) above, the defaulting Club is required to submit an explanation to the General Secretary at the latest within two days of the match. 	5. Any Club found to be in breach of this Rule will result in a fine in accordance with the Fines Tariff and may at the discretion of the Management Committee have points deducted from their total number of points gained. In addition, any other breaches of Rules uncovered by the checking of Photographs will be dealt with accordingly.	
18.R	If a player transfers to a new Club within the League, they must complete the required Transfer Form required by Rule 18H. Players must still be re-registered each year in accordance with Rule 18A.	
18.S	A player may have their registration cancelled by a Club providing the Registrations Secretariat is given written notification.	
18.T	Clubs shall keep a list of players it registers and a record of the games in which they have played, and shall produce such records upon demand by the Management Committee. Failure to comply will result in a fine not exceeding £20. At the request of a duly appointed Officer, (or agent), of the Competition, (and in the presence of that officer or agent), all players competing in a match will be required to list their names and provide a signature validating their details. Any discrepancies in the list so compiled will be subject to investigation by the Management Committee who may issue such fine/punishment, as they feel appropriate.	
18.U	Clubs shall be solely responsible for the discipline administration of their players and Club as advised and directed by Hertfordshire FA. The Competition will not be responsible for this administration or dealing with their discipline matters, these and any related questions should be dealt with via the Whole System or Hertfordshire FA.	
18.V	Any team not registering a minimum of eleven (11) players 14 days before the start of each playing season (Rule 18B 3); may be deemed to have resigned their membership by the Management Committee.	
18.W	A fee of £2 will be charged for the checking of Player Registrations or for the checking or supply of any other League forms/documents unless relating to a League Charge. A request for any such checking or documents and fee must be sent to the appropriate League Officer at least 48 hours in advance of requirement.

19.A	Every team must register the colour(s) and design of its shirts and shorts with the Secretary by 15 th May and the Competition Secretary shall decide as to their suitability.	
19.B	Any team wishing to change the colours and/or design(s) of its shirt(s) and short(s) during the Playing Season must obtain permission from the Competition Secretary in advance of making that change.	
19.C	Goalkeepers must wear colours which distinguish them from all other Players and the Match Officials.	
19.D	No Player, including the goalkeeper, shall be permitted to wear black or very dark shirts.	
19.E	Any Team not being able to play in its normal colours as registered with the Competition shall notify its opponents of the colours in which they will play (including the colours of the goalkeepers jersey) at least 5 days before the Competition Match.	
19.F	If, in the opinion of the referee, two Teams have the same or similar colours, the <i>home</i> Team shall make the change. Should a Team delay the scheduled time of kick off for a Competition Match by not having a change of colours they will be fined in accordance with the Fines Tariff.	
19.G	Shirts must all be numbered and no two shirts shall have the same number, failing which a fine will be levied in accordance with the Fines Tariff	
19.H	All outfield players kit must be of a matching, colour and design (reasonable makers logo's allowed on shorts and socks, but not full length stripes on sides of shorts or socks). Socks must be distinguishable from the oppositions, any sock tape or supports should match the main colour of the socks. Clubs that reach Cup Finals should ensure that all outfield kit is 100% matching. Failure to do so will result in a fine in accordance with the Fines Tariff.	

19.1	Any club reported for 19H above or any other kit issues not listed in 19A above shall be fined in accordance with Fines Tariff.
o. Pl	AYING SEASON. CONDITIONS OF PLAY, TIMES OF KICK-OFF. POSTPONEMENTS. SUBSTITUTES
20.A	All Competition Matches shall be played in accordance with the Laws of the Game as determined by the International Football Association Board.
	Clubs must take all reasonable precautions to keep their Grounds in a playable condition. All Competition Matches shall be played on pitches deemed suitable by the Management Committee. If through any fault of the home Team a match has to be replayed, the Management Committee shall have power to order the venue to be changed.
	If the Home clubs pitch becomes unavailable for any reason, a minimum of 24 hours prior to a match, the Competition may order the match to be played on either a neutral pitch or the opponents pitch if this can be arranged. Earlier pitch changes maybe allowed if both teams agree and this is feasible
	The Management Committee shall have power to decide whether a pitch and/or facilities are suitable for Competition Matches and to order the Club concerned to play its Competition Match(es) on another ground.
	Artificial Football Turf Pitches (3G) are allowed in this Competition provided they meet the required performance standards and are listed on the FA's Register of Football Turf Pitches - https://footballfoundation.org.uk/3g-pitch-register. All Football Turf Pitches used must be tested (by a FIFA accredited test institute) every three years and the results passed to The FA. The FA will give a decision on the suitability for use and add the pitch to the Register.
	The home Club is also responsible for advising Participants of footwear requirements when confirming match arrangements in accordance with Rule 20.C.
	Within the Regional NLS Feeder Leagues all Competition Matches shall have a duration of 90 minutes. All other Competition Matches shall have duration of 90 minutes unless a shorter time (not less than sixty (60) minutes) is mutually arranged by the two Clubs in consultation with the referee prior to the commencement of the match, and in any event shall be of equal halves. Two matches involving the same two Teams can be played on the same day providing the total playing time is not more than 120 minutes.

	No overhead netting is allowed for 9v9 and 11v11 affiliated matches
	Regional NLS Feeder Leagues: Overhead wires used to support pitch divider netting are removed for all affiliated matches at Regional NLS Feeder League level
	For those leagues which are not Regional NLS Feeder Leagues: Overhead wires used to support pitch divider netting are ideally removed for affiliated matches but if they cannot be removed then discretion is given to the match official to restart the match in accordance of the laws of the game
0.B	Except by permission of the Management Committee all Competition Matches must be played on the dates originally agreed but priority shall be given to The FA and parent County Association Cup Competitions. All other matches must be considered secondary. Clubs may mutually agree to bring forward a Competition match with the consent of the Competition. Failure to comply with this Rule will result in a fine in accordance with the Fines Tariff.

In the case of a revised fixture date, the Clubs must be given by the Competition 5 clear days' notice of the match (unless otherwise mutually agreed).

With reference to Rule 20B the wording "dates originally agreed this "shall taken as the dates set by the Competitions Fixtures Secretary and advised to clubs. The Competition may decide not to schedule matches on certain dates (E.G. Christmas, New Year, Easter Sunday and Mothers Day etc) but this may result in clubs having Double Headers / Evening matches in order to complete the seasons Fixtures. Failure to abide by this may result in matches being treated as unfulfilled fixtures and dealt with accordingly.

20.C An Officer of the home Club must give notice of full particulars of the location of, and access to, the Ground, time of kick-off and kit colours (including goalkeeper) to the Match Officials and an Officer of the opposing Club at least

	5 clear days prior to the playing of the Competition Match. The opposing Club must confirm receipt and give notice of its kit colours (including goalkeeper) at least 5 days prior to the playing of the Competition Match. If either is not provided, the relevant Club shall seek such details and report the circumstances to the Competition. Failure to comply with this Rule will result in a fine in accordance with the Fines Tariff.
20.D	In accordance with the Laws of the Game, the minimum number of Players which will constitute a Team for a Competition Match is 7. Failure to comply with this Rule will result in a fine in accordance with the Fines Tariff.
	1. In the event of a Club playing in any match and starting with less than 11 players, they may be fined for each missing player in accordance with the Fines Tariff.
20.E	Home and away matches shall be played. In the event of a Club failing to keep its engagement the Management Committee shall decide whether it should either :
	 award the points from the Competition Match in question to the Club's opponent (without the awarding of goals) OR
	 b. order the Competition Match to be rescheduled. The Management Committee shall also have the power to order the rescheduled Competition Match to be played on a neutral ground or on the opponent Club's Ground if they are satisfied that such action is warranted by the circumstances.
	In addition, the Management Committee may at its discretion order one or more of the following (if appropriate):
	a. impose a fine (in accordance with the Fines Tariff),
	b. deduct points from the defaulting Club,
	order the defaulting Club to pay any reasonable expenses incurred by the opponents.

That Club may apply to the Competitions Secretary, at least 5 days prior to the fixture, for postponement of their match.
24.B	Players can only qualify for selection for the Representative squad after they have played more than 3 games for their parent Club.
25. C	UP COMPETITIONS
25.A	The Competitions shall be called the Watford Sunday League Challenge Cup, The Intermediate Cup, The Junior Cup, The Chairman's Cup, The Invitation Cup, The Presidents Cup and the Reserve Cup, or by any other name, or names, as the Management Committee shall agree and may include a sponsor's name. 25.E	Except in the first round, all players must be registered members of their Club in The Association at least 7 days prior to the match. For the purposes of this Rule, entry of a Club to a Competition for the first time at later stages of that Competition will be considered to be their first round in that competition.
25.F	In all Cup Competitions no player may play for more than one Club in any competition.
25.G	Players under written contract, as described in Rule 18B(i) are not eligible for any Cup Competitions. With the exception of those players registered under contract with the same team operating at Step 1 to 6 of the National League System.
25.H	In the event of a Club being found guilty of playing an ineligible player, it shall be dealt with under Rule 18N and the match will be awarded to their opponents. If the match is a group stage League match, the defaulting Club may be excluded from the competition. Their record shall be expunged from the competition for the current season
25.1	Clubs drawn first will play on their home ground. In all matches, the Club drawn first will be responsible for all pitch expenses, officials fees will be equally between both clubs unless the Management Committee decides otherwise. 25.R	On the day of the match a team of 11 & 5 substitutes are to be selected from the 20 players named.
25.S	Should any match be abandoned owing to misconduct of players or spectators, the Management Committee shall have the power to order the result to stand irrespective of the time played. The Management Committee shall, at its discretion, expel the Club(s) at fault from the Cup Competition, or arrange for the match to be replayed with the offending team paying all match expenses. The offending Club(s) may also be charged under Rule 6P.

25.T	In all other matters the Rules of the South West Herts FA will apply, and any situation not covered by The Association Rules for Cup Competitions, shall be decided by the Management Committee.
25.U	The Competitions competed for under this nomenclature shall be, the Invitation Cup, the Presidents Cup and the Reserve Cup (or such other name as may be required and agreed by the Management Committee). They shall be conducted in accordance with the Laws of Association Football, the Herts FA Ltd and The Associations Own Rules, by the Management Committee of The Association.
25.V	The competitions are open to invited member Clubs of The Association. The Competitions may be played on a knockout basis or League basis, which will be determined by the Management Committee each season. If on a knockout basis extra time will be played with penalties. An entry fee of£3 may be charged if the Management Committee so decides. When this Competition is run on a League basis the first match in which each Club competes will be considered a first Round Cup Tie for the purposes of Association Rule 25E.
25.W	All other Rules will be applied as in the Competitions Cup Rules, and any matter not so covered will be decided upon by the Management Committee.
25.X	Any player sent off in a Cup Final shall not have their award presented at the end of the game, unless special dispensation is given at the discretion of the Management Committee.
25.Y	Both teams appearing in the Final shall be expected to wear smart dress for the Final and both teams will enter the field of play in Cup Final style as pre- advised before the final. Clubs in a Cup Final shall ensure that all their players are named with correct shirts numbers on the team sheet including substitutes and that it is completed correctly. All players including substitutes are to attend the presentation ceremony to collect their awards and also the after match clubhouse function, subject to rule 25(X). Failure to meet any of these requirements or any other improper behavior will be considered as undesirable conduct and the club or clubs concerned being charged. Failure to comply with this Rule will result in a fine in accordance with the Fines Tariff. Also the club of the offending player or players may face further action under Rule 12.
