- Retention and growth of traditional football participation (incorporating Adult Male, Youth and Mini Soccer) by working with affiliated clubs and leagues
- Retention and growth of The FA Charter Standard programme (clubs and leagues), including coordination of monitoring visits, annual health checks and organisation of the 'in service' development menu
- To develop links with the Education sector and provide strategic overview of the programmes delivered within schools, further education and higher education
