MATCH DATES

All ties must be played in week commencing Monday 8 September 2014, kick-off 7.00pm, unless mutually agreed otherwise. Clubs are reminded that when agreeing dates with opponents that ties in the FA Youth Cup Competition take priority over all other games with the exception of home first team commitments. This therefore means that matches in the Competition take priority over other Youth and Reserve team matches. If problems are experienced in fixing a date to avoid 1st XI fixtures, please contact the FA Competitions Department for assistance.

PLAYER QUALIFICATION DATE

The player qualification date is **12 noon on the day previous to the date fixed for playing the match**, this includes postponements. A “registered player” is one who is either, in the case of a player under written contract, registered with The Association or, in the case of a player without a written contract, registered with a League in which his Club competes in the current season. Any such registration must have been received and accepted by The Association or League by **12 noon on the day previous to the date fixed for playing the match**, and the registration must be continuous through to the date of the match.

AGE GROUP BRACKETS

Only those players are eligible to take part who have reached the age of 15 years by midnight on 31 August of the current season and not reached the age of 18 years as at midnight on 31 August of the current season. (For Season 2014-2015 a player must have been born on or after 1 September 1996 and before 1 September 1999).
