In accordance with Regulation 8.4.C, this form must be completed by every FA Registered Football Agent in respect of each Player/Coach with whom they have or have had a Representation Agreement during the Reporting Period. A signed copy must be provided to the Player within 30 days of the end of each Reporting Period. A copy should also be retained by the FA Registered Football Agent and must be provided to The Association within 14 days if requested.

If this Annual Return is provided to The Association, the data will be handled and processed as required by The FA to conduct its business and pursue its legitimate interests in accordance with The Association's privacy policy which can be found at <http://www.thefa.com/public/privacy>
