

RULES OF THE FA COUNTY YOUTH CHALLENGE CUP COMPETITION (“the Competition”)

1. CONTROL OF COMPETITION – RULES AND REGULATIONS

- (a) The ownership, organisation, control and management of the Competition and any rights associated with it of any nature shall be vested entirely and exclusively in The Association.
- (b) The Council shall have the power to make, delete and amend regulations for the organisation, control and management of the Competition as it, from time to time, deems expedient (the “Competition Rules”) subject only to the authority of The Association Board where such matters relate to financial or commercial matters. Unless explicitly provided for within the Competition Rules definitions of terms used within the Competition Rules are those included within the Rules of The Association for the relevant season.
- (c) All County Associations participating in any way in the Competition shall be bound by and comply with the Competition Rules (and any rules or regulations issued pursuant to the Competition Rules).
- (d) The Council shall have the power to appoint a Committee (the “Youth Committee”). The Youth Committee shall have the power to exercise all powers of the Council in relation to the Competition and to make decisions on all matters arising out of or in relation to the organisation, control and management of the Competition (including as to eligibility and qualification) which shall be deemed decisions of the Council and shall be final and binding on all participants in the Competition. In relation to these and any other matters not specifically mentioned in the Competition Rules, the Youth Committee shall, on behalf of the Council, have the power to take such action and make such decisions, orders, rulings and impose such penalties as it deems necessary and following such procedures as it considers appropriate and such shall, subject to Rule 24, be final and binding on all Participants. In considering such matters, the Council shall not be bound by any enactment or Rule of Law relating to the admissibility of evidence in proceeding before a Court of Law.

The Youth Committee shall have the power to appoint a Sub-Committee to exercise the powers of the Council in order to expedite decisions to ensure the progress of the Competition.
- (e) A County Association participating in the Competition shall have only such rights in relation to the Competition (and any match in the Competition) as are expressly granted to the County Association under the Competition Rules or by The Association in writing.
- (f) In addition to any other action or penalty, the Council shall have the power to disqualify any competing County Association, or Player for any competing County Association(s), which it determines to have breached the Rules of The Association or the Competition Rules (and any rules or regulations issued pursuant to the Competition Rules), and the decision of the Council shall, subject to Rule 24, be final and binding.

2. CONTROL OF COMPETITION – COMMERCIAL CONTRACTS

- (a) In relation to each match in the Competition, The Association shall itself be exclusively entitled to, or otherwise to authorise or grant to others, rights of access to and attendance at the ground of the Home County Association (“Access Rights”) for the purposes of transmitting or filming or otherwise recording on or by any media, any audio and/or visual materials depicting or describing all or any part or parts of a match (the “Copyright Materials”).
- (b) In relation to each match in the Competition, The Association shall itself be exclusively entitled throughout the world, or to grant to or otherwise authorise others:
 - (i) on a live, delayed, recorded or highlighted basis to broadcast or otherwise transmit by any method whatsoever (now known or hereinafter devised) the Copyright Materials by way of any and all forms of television or similar technology (now known or hereinafter devised) including, without limitation, free to air television, pay television, pay per view, “not-video-on-demand” internet or other on-line media and “video-on-demand” (the “Television Rights”).

- (ii) on a live or delayed basis to broadcast or to otherwise transmit the Copyright Materials (or audio) by way of radio broadcast or internet, or other on-line media or similar technology (now known or hereinafter devised) (the "Radio Rights").
 - (iii) to use, sell, publish, distribute and otherwise exploit the Copyright Materials in any manner whatsoever including, without limitation, clip licensing, videos, videograms, CD Rom, CDI, internet or other on line media (the "Footage Rights").
- (c) In relation to each match in the Competition, The Association shall be exclusively entitled, either by itself or to authorise others, to use sell or otherwise exploit all commercial and other marketing rights associated with the Competition including, without limitation, fixture list copyright, sponsorship, supplier rights, licences, perimeter board branding or other commercial arrangements (the "Marketing Rights").
 - (d) County Associations shall comply with the terms of all contracts entered into by The Association from time to time in relation to Access Rights, the Television Rights, the Radio Rights, the Footage Rights and the Marketing Rights (collectively the "Commercial Contracts") in relation to the Competition.
 - (e) County Associations shall provide access to grounds and provide all other rights, facilities and services as may be necessary to enable The Association to fulfil the Commercial Contracts.
 - (f) County Associations acknowledge that The Association may issue more detailed rules and regulations regarding the provisions of the Commercial Contracts (including, but not limited to in relation to, broadcasting, perimeter board advertising, interview backdrops, centre circle banners, side of goal mats, substitute/added time boards, tickets and match programmes) and the County Associations agree that they shall be bound by such rules and regulations as amended from time to time by The Association.
 - (g) Each County Association undertakes to indemnify and keep indemnified The Association and its officers, directors, employees and authorised representatives from and against any claims for direct or consequential loss or damage by any party to a Commercial Contract caused or otherwise attributable to any failure or any breach by the County Association fully to perform or observe its obligations and responsibilities under these provisions.
 - (h) Nothing in the above shall be construed or interpreted so as to prevent or restrict County Associations, subject to applicable FIFA, UEFA or other rules or regulations or decisions of The Association, from entering into commercial arrangements in relation to matches in the Competition which do not in any way conflict with the Commercial Contracts and duties of County Associations as set out herein (and in any other rules or regulations issued by The Association in accordance with this paragraph).
 - (i) The Association shall make provision for payments to County Associations as it shall from time to time consider appropriate.

3. NAME / LOGO AND IMAGES OF THE COMPETITION AND IMAGES OF THE CUP

- (a) The Competition shall be called 'The Football Association County Youth Challenge Cup' and should be marketed under the title 'The FA County Youth Cup' (the "official title") unless determined otherwise by the Council from time to time.
- (b) Each County Association shall include the Official Title at least once on all (if any) materials produced by or on behalf of it which relate to the Competition (including, but not limited to, tickets, programmes, press releases and where possible scoreboard displays) and shall refer to the Official Title at least once over (any) public address system operating on the day of each FA County Youth Cup match.
- (c) The Association may from time to time issue a FA County Youth Cup Logo. The FA County Youth Cup Logo may incorporate branding for a sponsor of the FA County Youth Cup.
- (d) Each participating County Association shall include The FA County Youth Cup Logo on all FA County Youth Cup communication materials produced by or on behalf of it (including, but not limited to, the front page of each FA County Youth Cup match programme, match tickets (if it is not possible to include The FA County Youth Cup Logo on tickets the County Association shall include a reference to the Official Title), fixture posters, stadium giant screens (if any) and County Association websites).

- (e) The Association may from time to time issue images of The FA County Youth Cup to County Associations. The ribbons attached to The FA County Youth Cup in the image will incorporate branding for the lead FA County Youth Cup sponsor.
- (f) If a County Association which wishes to use an image of the FA County Youth Cup it shall use the image issued by The Association and will follow any directions issued by The Association in relation to the use of such image.

4. ORGANISATION OF THE COMPETITION

- (a) The Organisation of the Competition shall be at the discretion of the Council.
- (b) The First and Second Round draws shall be made on a geographical basis.

5. ELIGIBLE COUNTY ASSOCIATIONS

- (a) Participation in the Competition shall be open to all Affiliated County Football Associations with matches played on a knock out basis.
- (b) Entries from off-shore County Associations will be considered on an annual basis and if accepted, special provisions may apply to such County Associations as stated in Appendix 2.

6. ENTRY DATE

A County Association wishing to participate in the Competition must complete the application and payment process on or before 1 June previous to the season in which such County Association proposes to compete in the Competition.

7. PROVISIONS FOR WITHDRAWING FROM THE COMPETITION

- (a) Any County Association intending to withdraw from the Competition must notify its intention to do so to The Association and the opposing County Association, not less than eight days before the date fixed for playing the match.
- (b) A County Association failing to comply with this shall be reported to the Council, who shall have power to compel such offending County Association to pay the expenses incurred and to take such other action as the Council considers appropriate.
- (c) If a County Association decides to withdraw from the Competition after a postponed or abandoned match, notice must be given to The Association and its opponent at the end of the match.
- (d) A County Association failing to give satisfactory reason for withdrawing from the Competition shall in addition to any other action considered appropriate not be allowed to enter the Competition in the following season and shall be liable to such fine as the Council considers appropriate.
- (e) Where a County Association fails to fulfil any fixture the Council shall take such action as it deems appropriate.

8. DRAWS FOR ROUNDS AND KICK OFF TIMES

- (a) The County Associations competing in each Round of the Competition shall be drawn in couples. The couples shall play a match subject to the Laws of the Game. The winners will compete in the next Round and be drawn in the same manner. This shall be continued until the Final of the Competition.
- (b) After the draw for each Round is made, notice shall be given to each County Association of the name of its opponent County Association and the closing date when the match shall be played. All matches in each Round shall be played on such a date and at such a time as the Council shall determine. The time of kick-off shall be mutually agreed between both County Associations subject to the approval of the Council. When a County Association has received permission to arrive the night before a match in accordance with Competition Rule

20(c)(i) the County Association drawn at home must arrange the time of kick-off to ensure that their opponents arrive back at its starting point before midnight. The Council shall have the power to order the kick-off to be changed, as it deems appropriate. Any late kick-off shall be reported by the Referee to The Association and the Council shall have the power to impose a fine.

- (c) County Associations first drawn must advise the agreed date and all other match details by completing the Match Arrangement Form which must be received by The Association and away County Association within seven days of receipt of the draw.
- (d) The County Association drawn at home must give its opponents the choice of two **weekend** dates of when the match is to be played. If the County Associations fail to agree on the dates offered then the County Association drawn at home has the choice of date and must give its opponents at least 14 days notice in writing of the date selected.
- (e) All matches are to be played on a **weekend date** unless mutually agreed otherwise.
- (f) The County Association drawn at home shall arrange for the ground and other match requirements.
- (g) Any dispute in choice of date and kick-off time shall be referred to the Council, whose decision is final.

9. VENUE FOR MATCHES

- (a) *Venue*
 - (i) The County Association first drawn shall be entitled to have the match played on the ground of its choice, subject to that ground fulfilling the requirements of the Competition Rules and the consent of Council obtained.
 - (ii) The Council shall have the power to order that any match be played on an alternative ground, including a 3G football turf pitch that meets the requirements of Competition Rule 13(a)(i)(a) and (b) below, or date, including a Sunday, if it is considered appropriate and necessary.
- (b) *Protests Regarding the Suitability of Ground*
 - (i) A County Association may protest to the Council that the home venue is unsuitable for the match. Such protest must be made to the Council and must be accompanied by a fee of £250.00, which may be forfeited if the protest is not sustained.
 - (ii) The Council shall have the power to consider the protest in such manner and following such procedures as it considers appropriate. The Council may amongst other things order the match to be played on the ground of the protesting County Association, or on a neutral ground. The payment of the costs incurred by either County Association and The Association incidental to the protest shall be at the discretion of the Council.

10. DURATION OF MATCHES, EXTRA TIME AND KICKS FROM THE PENALTY MARK

- (a) The duration of each match shall be 90 minutes, except in special cases, provided for in these Competition Rules, where an extra 30 minutes shall be played. The Referee shall allow for time wasted or lost through accident or other cause. The Referee is the sole judge of allowance of time whether lost through accident or other cause and his decision on this matter is not subject to appeal.
- (b) The half-time interval shall be 15 minutes for all ties in the Competition.
- (c) Both teams shall enter the field of play together five minutes prior to the kick-off time, along with the Match Officials.
- (d) *Extra Time and Kicks from the Penalty Mark*
 - (i) If a match is drawn after 90 minutes, an extra 30 minutes shall be played and 15 minutes shall be played in each half.

- (ii) If the score is still level at the end of extra time, kicks from the penalty mark shall be taken to determine the winner, in accordance with the procedure adopted by The International Football Association Board.

11. POSTPONED AND ABANDONED MATCHES

(a) Matches which are Postponed

- (i) When a match has been postponed, it shall be played within 14 days of the date fixed for the first match on a ground of the first drawn County Association.
- (ii) If the first match be again postponed it shall be played as directed by The Association.

(b) Abandoned Matches

When any match has been abandoned after it has commenced but before it has been completed, The Council shall deal with the matter as it sees fit in its absolute discretion.

- (c) The Council shall have the power to vary these arrangements if it is deemed necessary.

12. REPORTING RESULTS

- (a) Each County Association shall confirm the result of the match, with the names of their players competing and goal scorers, together with the marking of the Referee's performance to be received at The Association within two days of the match, Sundays not included.
- (b) Each County Association shall communicate the result and other details as required to The Association and designated press agencies immediately after the end of the match, according to the instructions issued prior to the match.

13. FACILITIES AND EQUIPMENT

(a) Dimensions of Field of Play and Ground Facilities

- (i) 3G football turf may be used in the Competition provided conditions (a) to (c) below have been met (the "Performance Standard"):
 - (a) The pitch must be surfaced with 3G football turf that has laboratory type approval according to the FIFA Quality Concept for Football Turf (2012 & 2015 editions) – to a minimum of FIFA Recommended One Star/Quality level and must have satisfied the performance and construction requirements at the time of its most recent annual assessment.
 - (b) The 3G football turf pitch must be listed on The Association's register of 3G football turf pitches by no later than 31 July prior to the commencement of the Competition.
 - (c) Where a 3G football turf pitch is not yet listed on The Association's register (for example if it is a newly installed pitch), a County Association must obtain a Performance Test Certificate and submit it to The Association by no later than 31 July prior to the commencement of the Competition.
 - (d) The Association reserves the right to instruct a County Association to have its pitch tested at any time in order to ensure that it meets the Performance Standard. All such tests shall be at the County Associations expense.
 - (e) The Association may order a tie to be played at an alternative venue where it is not satisfied the pitch meets the Performance Standard.
 - (f) 3G football turf, including run-offs, shall be one continuous playing surface and shall be green in colour at least one metre from the outer edge of the touchline and goalline. All line markings shall be in accordance with the Laws of Association Football.

- (g) The home County Association shall allow their opposition the opportunity to use the pitch and train on the surface two hours prior to the kick-off and there must not be another game or event on the pitch following the training period. If it is intended to water the pitch before the match, the pitch shall be watered prior to the training period.
- (h) The County Association using the 3G football turf shall advise their opposition at least 10 days before the match of limitations or recommendations on the types of boot or stud that may be used on the surface.
- (i) The County Association shall provide all necessary assistance and data relating to player assessments, injury records, maintenance etc as requested by The Association, FIFA or UEFA.
- (ii) The dimensions of the field of play for matches shall be as follows:
 - Maximum length: 110 metres
 - Minimum length: 100 metres
 - Maximum breadth: 75 metres
 - Minimum breadth: 64 metres
- (iii) A County Association must have use of an enclosed ground where charge for admission must be made and the attendance must be taken in all matches in the Competition.
- (iv) Goal nets must be used in all matches.
- (v) The playing area must be enclosed by a permanent fixed barrier, the only exception being those areas and spaces excluded from spectator viewing. Wire may not be used, in rope form, to connect the posts.
- (vi) Dressing and washing accommodation must be separate for each team and Match Officials. Dressing Rooms must have heating and hot water and be secure and independent of any public access. Dressing room areas must be cleaned and maintained to a satisfactory standard. A call up bell must be provided in the Match Officials dressing room and connected to each team dressing room.
- (vii) Separate toilets must be provided for dressing rooms used by players and Match Officials, which must not be available for spectator use.
- (viii) Entrances and exits must be provided to cater for the anticipated attendance. Access for emergency services must be provided.
- (ix) Each County Association shall provide separate areas adjacent to the pitch for the sole use of Team Officials, medical staff and substitutes. Such designated areas shall be clearly marked "Home" and "Away", have direct access to the pitch, be located as near as possible equidistant from the halfway line and be under cover. The Team Benches should also comply with Competition Rule 18.
- (x) Public Liability Insurance must be in place.
- (xi) Hospitality for Visiting County Association Officials must be provided in a designated area.
- (xii) Ladies and Gentlemen's toilets, other than those used by players and Match Officials, must be provided for spectators throughout the duration of matches.
- (xiii) Refreshment facilities for spectators must be provided in all areas.
- (xiv) Covered accommodation for spectator use must be provided.
- (xv) Hard standing (concrete/paving slabs or other suitable approved material) must be provided to a minimum width of one metre on at least the entire length of one touch-line.
- (xvi) A technical area is to be provided. The technical area extends one metre on either side of the designated seated area and extends forward up to a distance of one metre from the touch-line. Markings are to be used to define this area.

(xvii) A telephone must be connected and available at the ground.

(b) *Playing Condition of the Ground*

- (i) Each County Association must take every precaution to ensure that the ground they are using is in a fit playing condition.
- (ii) A County Association may protest to the Council in relation to the playing condition of a ground as in Competition Rule 9(c).
- (iii) A Referee shall whenever possible examine the ground and decide as to its fitness for play in sufficient time to save the expense of unnecessary journeys being incurred by County Associations. The pitch inspection must be made by the Match Referee or a Referee appointed by The Association or a County Football Association who must immediately contact The Association with details of an inspection (and the Match Referee if relevant).
- (iv) Subject to this Rule, the Referee shall have the power to decide as to the fitness of the ground in all matches.
- (v) The Referee must report to the ground 90 minutes before the time of kick-off. If necessary, the Home County Association or The Association may, by notice, require the Referee to visit the ground more than 90 minutes before the time of kick-off any time during the season.
- (vi) No other activity is permitted to be played on the pitch, on the day of the match, prior to an FA County Youth Cup tie in all rounds of the Competition without prior written consent of The Association.

(c) *Floodlighting*

- (i) Where it has been agreed to play a match under floodlight conditions, the Council shall have the power to order that the kick-off time shall be 3.00pm.
- (ii) The Referee will decide at what point in the game the floodlights shall be switched on. This will necessitate a discussion with responsible Officials of the competing County Associations before the game, when a signal must be agreed.
- (iii) The cost for floodlighting must not exceed £50.00, and this cost may be charged as match expenses, if incurred.

(d) *First Aid*

It is the responsibility of the Home County Association to ensure that First Aid facilities, equipment and a stretcher are available for all matches and a fully qualified person is present to administer First Aid.

14. COUNTY ASSOCIATION COLOURS

- (a) The two competing County Associations must wear colours that distinguish them from each other and also the Match Officials. Where there is a clash (as determined by The Association), the Away County Association must change.
- (b) In the event of the County Associations not agreeing upon the colours to be worn, The Association shall decide. Goalkeepers must wear colours which distinguish them from the other players, and the Match Officials.
- (c) County Association's colours must not clash with the black and white outfit worn by the Match Officials.
- (d) Players' shirts shall be clearly numbered on the back in accordance with the Official Team Sheet. No change of numbers during the match shall be allowed except on a change of Goalkeeper or where a player has been required by the Referee to change his shirt because of a blood injury. The Captain of each team shall wear a distinguishing armband to indicate his status.
- (e) Advertising may be worn on players' clothing in accordance with the Rules of The Association and the Laws of the Game. When participating in a match no Player shall reveal

undergarments that show political, religious or personal slogans, statements or images or advertising other than a manufacturer's logo.

- (f) The inclusion of any reference whatsoever in or on clothing or equipment of a County Association team to a product or service or other activity which is detrimental to the welfare, health or general interest of young persons, or is otherwise considered inappropriate having regard to the age of the players, is prohibited.

15. PROVISIONS CONCERNING PLAYERS

- (a) Each team participating in a match shall represent the full available strength of each competing County Association. **Club teams shall not be permitted to represent a County Association in this Competition.**
- (b) A maximum of **seven** substitutes may be nominated. Subject to the below a County Association may at its discretion use three substitute players at any time in a match. In the event that extra time is played in any match, a County Association may at its discretion use one additional substitute player (a fourth in total) from the nominated **seven** substitutes, during such period of extra time. A substitution can only be made when play is stopped for any reason and the Referee has given permission. Prior to the substitution being made the County Association must identify to the Match Officials the number of the player out and the player in, in accordance with the Official Team Sheet.
- (c) All players shall be qualified as players according to the Rules of The Association.
- (d) A player shall not play for more than one County Association in the Competition in the same season.
- (e) A player who has been suspended according to the disciplinary procedures under the Rules of The Association may play in a postponed or replayed match after the term of his suspension has expired.
- (f) A substitute who does not play in a match is entitled to play for another County Association in the Competition in the same season.
- (g) (i) Each County Association shall provide a list of names of players taking part in the match (including the names of substitutes) (the "Official Team Sheet") to the Referee and a representative of their opponents in the presence of the Referee:
- 75 minutes before kick-off for the Final.
 - 45 minutes before kick-off for all other matches.
- Each player's date of birth must be indicated on the Official Team Sheet. Any County Association failing to do so will be liable to be fined by the Council a sum not exceeding £100.00. Any objection to the age qualification of a player should be made to a representative of their opponents before kick-off.
- (ii) Should any nominated player or substitute sustain an injury after the submission of the Official Team Sheet to the Referee and before the kick-off, he may be replaced without fine if he is injured warming up after the exchange of the Official Team Sheet, provided the Referee and opponents are informed before the commencement of the match. In such circumstances the Official Team Sheet must be updated by the relevant County Association to include the replacement player and exclude the injured player prior to the commencement of the match.
- (iii) No player shall be eligible to take part in a match unless their name appears on the Official Team Sheet.
- (h) In the case of postponed matches only those players shall be allowed to play who were eligible on the date fixed for the playing of the original match, except under the provisions of Competition Rule 15(e).
- (i) Only those players are eligible to take part who have reached the age of 15 years by midnight on 31 August of the current season and not reached the age of 18 years as at midnight on 31 August of the current season. (For season 2019-2020, a player must have been born on or after 1 September 2001 and before 1 September 2004).

- (j) A player under written contract, including Scholarship players, and those registered, including Trialists, at an Academy licensed by The Professional Game Board shall not be eligible to compete. [The terms "Academy" and "Trialists" are as defined in the Youth Development Rules.]
- (k) The Secretary of each County Association shall be the person held responsible for ensuring that each player taking part in his County team in any match in the Competition is qualified to do so.
- (l) Birth Certificates or other satisfactory proof of date of birth must be produced for scrutiny by a representative of the opposing Association if requested providing that such requests be made at least five days prior to the match.
- (m) A player shall be eligible to play for the County of his birth, or he must be a registered playing member of a Club in membership with the parent County Association for which he is selected to play by 12 noon on the day immediately prior to the date fixed for playing the match and the registration must be continuous through to the date of the match. Providing he is qualified as above, a player shall have the choice of the County Association for which he wishes to play.

All Clubs in current membership with a County Youth Association are considered to be in membership with their County Association.

16. VALIDITY OF PLAYERS' QUALIFICATIONS

- (a) The Council shall have power to call upon a Player, and/or the County Association to which he is registered, or for which he played, to prove that the Player is qualified according to the Competition Rules.
- (b) Subject to (c) below, where a player that is or is found to be ineligible under either the Rules of the Competition and/or the Rules of the Association plays for a County Association in a Competition match, the Council shall remove the County Association from the Competition, and may impose further penalties against the County Association.
- (c) However, where the County Association satisfies the Council that the County Association (or any of its officers) did not know and could not reasonably have known, even had it made every reasonable enquiry (with the exercise of the utmost caution), that the player was ineligible, the County Association shall not be removed from the Competition but may still be subject to any other penalty. (e.g. fine, ordered to replay the match).

17. PROGRAMME

A Programme or Team Sheet must be produced for spectators with details of both teams.

18. TEAM BENCHES

- (a) In all Rounds of the Competition, the number of County Association players and Officials seated on the team benches, in the designated technical area, must not exceed 11 unless the team bench facility provides more than 11 individual seats.
- (b) Only one person has the authority to convey tactical instructions to the players during the match. He is allowed to move to the edge of the technical area to issue instructions to his team.
- (c) All Team Officials and substitutes seated on the bench shall be listed on the Official Team Sheet when it is submitted to the Match Officials. Only those persons listed on the Official Team Sheet shall be permitted in the technical area.
- (d) The occupants of the technical area must behave in a responsible manner at all times. Misconduct by occupants of this area will be reported by the Referee to The Association, who shall have the power to impose sanctions as deemed fit.
- (e) With the exception of the Team Manager, the Team Coach and any substitutes who are warming up or warming down, all other personnel are to remain seated on the team bench. The Team Manager or Team Coach is allowed to move to the edge of the technical area to issue instructions to his team.

- (f) In the Final, County Associations will be advised by The Association of the number of technical staff and substitutes who may occupy the team benches and a list of the permitted number of authorised personnel must be provided by each County Association to the Referee at least 60 minutes before kick-off.

19. PROVISIONS CONCERNING MATCH OFFICIALS

- (a) (i) Match Officials shall be appointed by The Association in accordance with its appointing procedures from time to time.
- (ii) The Association reserves the right to appoint a Reserve Official to officiate in the event of an appointed Match Official failing to arrive or being incapacitated.
- (iii) In the event of any of the Match Officials failing to arrive or being incapacitated, it shall be completed under the control of the remaining Match Officials unless the competing County Associations are able to agree upon a substitute who is acceptable to the Match Referee; should the appointed Match Referee fail to appear then the most senior Assistant Referee must take charge. Any substitute agreed for a match shall be considered a Match Official for the purposes of that match.
- (b) The fees and expenses of all Match Officials appointed by The Association to officiate in any match prior to the Final shall be paid by the Home County Association unless otherwise instructed by Council.
- (c) *Scale of Expenses to be Paid to Match Officials*
- (i) In all rounds of the Competitions standard class railway fares operating on the day of the match will be allowed.
- (ii) An allowance of £0.40 per mile will be allowed to all Match Officials officiating in the competition who travel by private car.
- (iii) In Rounds prior to the Semi-Final, Match Officials shall be entitled to claim meal allowances where the travelling time exceeds six hours £4.00.
- (iv) In the Semi Finals and Final, Match Officials shall be entitled to claim meal allowances as under:
- Where the travelling time exceeds 8 hours £10.00
Where the travelling time exceeds 6 hours £8.00
Where the travelling time exceeds 4 hours £6.00
- Meal allowance travelling times shall be calculated from the time the Match Officials leaves home until the match Officials return home, less the duration of the match.
- (d) *Scale of Fees to be Paid to Match Officials*
- (i) In all rounds prior to the Semi-Finals
Referee **£53.00**; Assistant Referees **£34.00** each
- (ii) *Semi-Finals*:
Referee **£100.00**; Assistant Referees **£50.00** each; Fourth Official **£34.00**
- (iii) *Final*:
Referee **£150.00**; Assistant Referees **£75.00**; each Fourth Official £50.00 and a Souvenir Medal each.
- (iv) The above fees, prior to the Final, shall be paid by the Home County Association. The fees for the Final will be paid by The Association.
- (e) In the event of The Association giving permission for a pitch inspection prior to a match, by an Official other than the Match Referee, such Official shall be entitled to expenses plus half the match fee if not local. The Home County Association will pay any expenses.
- (f) Match Officials are entitled to their travelling expenses if incurred. Half their fees will be paid if the match to which they are appointed is postponed after they have arrived at the ground.

- (g) In the event of a Match Official being unable to reach their destination going to or returning from a match without staying at an hotel, they shall be entitled to charge £40.00 for each night to cover their hotel expenses. A receipted hotel account must be provided.
- (h) Match Officials shall acknowledge acceptance of appointments for all matches in the Competition to The Association.
- (i) The Home County Association must notify the Match Officials of the precise details of the match, this is to include a map with the location of the ground indicated, kick-off time, colours of both teams and other necessary details to be received by the Match Officials not later than five days prior to the match who shall acknowledge receipt.
- (j) The duties of the Match Officials shall be as defined in the Laws of the Game.

20. PROCEEDS OF MATCHES PRIOR TO THE FINAL

(a) *Proceeds of Matches*

In all matches, The Association shall take the receipts from all matches and shall pay the expenses.

(b) *Payments of Travelling Expenses*

- (i) In all Rounds, match expenses shall include travelling expenses, actually incurred, which must not exceed £3.00 per coach mile. If private cars are used, then the expenses which can be claimed will be for a maximum of five cars at £0.40 per mile. For ties involving travel to/from offshore Associations, air/sea travel at the cheapest rate are allowed to be claimed.
- (ii) The travelling expenses for the visiting County Association are to be calculated on a direct route from the starting point, to the ground where the match is being played.
- (iii) Where travelling by rail, the cost of 25 standard class fares at the cheapest available rate may be claimed.

(c) *Hotel Expenses*

- (i) Where it is necessary for County Associations to arrive the night before a match, application for hotel expenses must be submitted in writing to The Association within 14 days of receipt of the Draw.
- (ii) The grounds for making such an application are that it would be necessary for the visiting County Association to depart from its County Headquarters before 8.00am on the day of the match **in order to arrive at the venue for the match no less than 90 minutes prior to the scheduled kick-off, based on reasonable travel time only (determined by reference to the AA Route Planner service) and including a stop of not more than 45 minutes.** Expenses, which may be claimed, if actually incurred, shall not exceed £40.00 per person per night for 25 persons.
- (iii) A County Association that has been granted hotel expenses by The Association must stay within a 30 mile radius of the ground where the match will be played.

(d) *Other Allowable Expenses*

- (i) A sum not exceeding £150.00 (where incurred) may be charged for the use of a ground when a hiring charge is incurred.
- (ii) The cost for floodlighting must not exceed £50.00, and this cost may be charged as match expenses, if incurred.
- (iii) Lunch allowance for the Away County Association only (where necessary) shall not exceed £5.00 per person for 25 persons. This shall only be allowed where the travelling time exceeds two and a half hours or travel over 80 miles prior to the tie. Gratuities and/or service charges cannot be claimed.
- (iv) For meals after the match only the Home County Association may claim an allowance which shall not exceed £10.00 per person for 50 persons, this includes 25 persons for the Away County Association. Gratuities and/or service charges cannot be claimed.

- (e) The following items must not be charged as match expenses:

- (i) Telephone calls
 - (ii) Printing of Programmes
 - (iii) Stewards
 - (iv) Groundsmen
 - (v) Dressing Room Attendants
 - (vi) Light Refreshments before, during and after a match
 - (vii) Gratuities
 - (viii) Footballs
 - (ix) Cost of Dressing Rooms
 - (x) Expenses of advertising, printing and postage
 - (xi) Police and gatemen
 - (xii) Ground hire when a County Association uses its own Ground.
 - (xiii) Expenses and fees of Fourth Officials prior to the Semi-Finals, unless appointed by The Association
 - (xiv) First Aid
- (f) County Secretaries are asked to note that travelling expenses and meals must not be overcharged and that the travelling expenses of their players should be itemised.
 - (g) All payments must be supported by vouchers or signed receipts. The Home County Association must submit to The Association within 14 days of the match, together with the balance of the receipts, a match statement made out on the approved form.
 - (h) The Away County Association must submit to The Association, all accounts connected with the match, and allowed by Rule against the gate, within 14 days of the match being played, otherwise the claim shall be considered invalid (unless a satisfactory explanation be given).
 - (i) The Home County Association shall clear all such accounts and comply with the other requirements of this Competition Rule.
 - (j) If the receipts are not sufficient to cover the entire expenses of the match the Home County Association shall pay the accounts in excess of the receipts.
 - (k) Where the match results in a loss, the County Association bearing such loss may apply for a refund of this loss within 28 days after the date on which the match was played.
 - (l) When a match is postponed through causes over which neither County Association has control, the expenses shall be paid out of the receipts of the second match.
 - (m) In any match ordered to be replayed in consequence of a breach of Competition Rule, the County Association in default shall only receive the approved travelling costs in accordance with this Competition Rule, except with the consent of the Council which will only be given under special circumstances.

21. PROVISIONS FOR THE FINAL

- (a) The Association shall determine the ground for the Final and shall have direct control of the arrangements.
- (b) If the match is drawn after 90 minutes, an extra 30 minutes shall be played and 15 minutes shall be played in each half.
- (c) If the score is still level at the end of extra time, the winner shall be determined by the taking of kicks from the penalty mark in accordance with the procedure adopted by The International Football Association Board.
- (d) *Postponed Match*
When a Final match has been postponed it shall be played as directed by The Association.
- (e) *Abandoned Match*

When a Final match has been abandoned after it has commenced but before it has been completed, the Council shall deal with the matter as it sees fit in its absolute discretion.

- (f) The Council shall have the power to vary these arrangements if it is deemed necessary.

22. THE FA COUNTY YOUTH CUP / FINALIST MEDALS

- (a) The Cup is the property of The Association. When the winning County Association has been ascertained, The Association shall loan the Cup to such County Association, which shall be responsible for its return to The Association on or before the first day of March in the ensuing year in good order and condition. The Association reserves the right to request the return of the Cup at any time by giving seven days notice. Should the Cup be lost, destroyed or damaged by fire or any other cause whilst under the care or custody of the County Association, the latter shall refund to The Association the amount of its current insured value or the cost of thorough repair in addition to any other penalty which The Association may impose.
- (b) In addition to the Cup, the Association shall present 25 medals to playing staff and officials of both County Associations in the Final. When a player taking part is ordered to leave the field of play for misconduct, the medal to which he may be entitled may be withheld at the discretion of the Council.

23. PROVISIONS CONCERNING PROTESTS

- (a) All issues relating to the interpretation of the Competition Rules, shall be referred to the Council, whose decision shall, subject to Rule 24, be final and binding. The Council shall consider any such matter in such manner and following such procedures as it considers appropriate. The Council shall not be bound by any enactment or Rule of Law relating to the admissibility of evidence in proceeding before a Court of Law.
- (b) Where a County Association wishes to protest that there has been a breach of the Competition Rules, such protest must be made in writing and must contain the particulars of the grounds upon which it is made. The protest must be received by The Association, accompanied by a fee of £100.00, within two days of the match to which it relates (Sundays not included). The fee may be forfeited to The Association in the event of the protest not being sustained.
- (c) The Council may make such orders as it considers appropriate in relation to any issue or protest referred to it. The Council may make such orders as it considers appropriate as to the costs incurred by the parties or The Association.
- (d) Any protest relating to the ground, goal posts or bars or other appurtenances of the game shall not be considered by the Council unless an objection has been lodged **by a duly authorised representative on behalf of the Visiting Club with a duly authorised representative on behalf of the Home County Association in the presence of the Referee** at least one hour before the official time of the kick-off. The Referee shall require the Home County Association to correct the cause of the objection, if this is possible without unduly delaying the progress of the match. **The Referee shall record the lodging of any protest made under this Rule in his match report.**
- (e) Where an objection has been lodged with the Referee and Home County Association as above, a protest must be made to The Association and neither objection nor protest may be withdrawn, except by leave of the Council.
- (f) The Association shall send a copy of any protest to the County Association protested against, which shall lodge a defence to the protest with particulars of the defence within two days of receipt of the protest.
- (g) Members of the Council directly connected with a County Association concerned in a protest shall not have any involvement in the consideration of the matter.
- (h) A County Association, or player or any person directly connected with the management of the County Association may be summoned to attend at a hearing of a protest. A County Association may be represented by one or more persons. A Barrister or Solicitor may represent a County Association only with the prior written consent of the Council. Any

person summoned to attend a hearing of a protest must attend personally and shall not be legally represented except with the prior written consent of the Council.

24. PROVISIONS CONCERNING APPEALS

- (a) A County that is expelled from the Competition may appeal against that decision to an appeal board in accordance with the procedures for FA appeals.
- (b) For the avoidance of doubt, a County may not appeal against any penalty imposed on it other than expulsion from the Competition.

25. NOTICES

All notices required to be given to The Association by any of these Competition Rules shall be addressed to the Competitions Manager, at the offices of The Association.
