STANDARD SUBCONTRACTING AGREEMENT FOR FA AUTHORISED AGENTS

Under the terms of The FA Football Agents Regulations (and in particular Regulation H.4), where an Authorised Agent assigns or subcontracts any Agency Activity duties or services or responsibilities, the Authorised Agent must fulfil certain obligations. The FA has produced this standard template to assist Authorised Agents in ensuring that subcontract or assignment arrangements are properly documented and disclosed.

WHEREAS

APPOINTMENT

1. The Authorised Agent hereby appoints the Subcontracted Authorised Agent to provide services on the following terms:

OBLIGATIONS

4. The Authorised Agent and the Subcontracted Authorised Agent each undertakes and warrants that at all times during the term of this Agreement each shall comply with the Rules of the Football Association and the Football Agents Regulations;
5. The Subcontracted Authorised Agent agrees that he shall provide the Services in accordance with the Obligations as set out in the Representation Contract between the Authorised Agent and the Client.
6. The Authorised Agent warrants and confirms that he has a valid and active representation agreement with the Client and that the Client has provided his/its prior written consent to the subcontracting of the Services in this Agreement.
